Average Annual Financial Turn Over during the last 3 years ending( i.e. FY 2020-21, 2021-22 and 2022-23) should be at-least 40% of estimates cost.</p> <p>(xvi)Valid UDYAM Certificate, if applicable.</p> <p>(xvii) The Bidder must not be black-listed for Telecom business by any Central/ State Governments/ PSUs/BSNL in India at the time of submission of bid. An <b>undertaking</b> must be submitted in this regard.</p>

- 3. In case of bidding for multiple Zones, one Cumulative EMD and Tender fee amount for all the Zones, for which bids have been submitted, shall be accepted. Bidder will have option to apply in all Zones or Zone of their choice. L1 bidder will be decided Zone-wise. The evaluation of the Tender will be done Zone wise.**
